The United Republic of Tanzania has received financing from the African Development Bank hereinafter called the Bank toward the cost of the **Supply and Commissioning of Two (2) Search and Rescue Boats for Multinational Lake Victoria Maritime Communication and Transport (MLVMCT) Project** and intends to apply part of the proceeds toward payments under the contract for Supply and Commissioning of Two (2) Search and Rescue Boats for the MLVMCT Project. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the Bank's Disbursement Guidelines and procedures for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit. The project is exempted from Value Added Tax (VAT).
2. The Tanzania Shipping Agencies Corporation now invites sealed Bids from the eligible bidders for Supply and Commissioning of Two (2) Search and Rescue Boats for Multinational Lake Victoria Maritime Communication and Transport (MLVMCT) Project. The delivery point is Mwanza Port and the delivery shall be accomplished within a period of nine (9) months from the date of signing the contract.
3. Bidding will be conducted through the Open Competitive Bidding (International), (OCBI) method as specified in the Bank's Procurement Framework , and is open to all eligible bidders as defined in the Procurement Framework.
4. Interested eligible Bidders may obtain further information from the website of the Tanzania Shipping Agencies Corporation www.tasac.go.tz and/or from office of the Secretary, TASAC Tender Board Head Office, at Nkurumah Street, SUMATRA House Floor 4 (Room 412), P.O. Box 989, Dar es Salaam from 0800 to 1700 local time Mondays to Fridays inclusive except on public holidays.
5. A complete set of Tendering Documents in English and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 4 above and upon payment of a non-refundable fee of Tanzanian Shillings One Hundred Thousand Only (TZS.100,000.00) or equivalent in any other convertible currency. Payment should either be by Cash or Banker's Cheque, payable to Director General. Payment Control No. should be received from the Corporation before making payment.
6. Pre-bid meeting will be held on 9th January, **2024** at TASAC Head Office, Nkurumah Street, SUMATRA House Floor No. 2 (Board Room), at 10.00 a.m Local time

7. All Tenders in one original plus Two Copies, properly filled in, and enclosed in plain envelopes must be marked "Tender No. AE/095/2022-2023/HQ/G/28 Supply and Commissioning of Two (2) Search and Rescue Boats for Multinational Lake Victoria Maritime Communication and Transport (MLVMCT) Project, be delivered to the Secretary, TASAC Tender Board, and Procurement Office, Nkurumah Street, SUMATRA House Floor 4 (Room 411) on or before **Tuesday 6th February, 2024** at 1400 local time. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at TASAC Board room Nkurumah Street, SUMATRA House.
8. All tenders must be accompanied by a Tender Security of **USD 40,000** or equivalent in any convertible currency in an acceptable form as provided in the bidding document.
9. Attention is drawn to the Procurement Framework requiring the Borrower to disclose information on the successful bidder's beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the bidding document.
10. Late Tenders, portion of Tenders, electronic Tenders, Tenders not received, and not opened and not read out in public at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
