# ANNOUNCEMENT

## ORAL EXAMINATION FOR DECK AND ENGINE CANDIDATES

1. Oral Examination for both deck and engine candidates will be conducted in Dar es Salaam from Monday, 01<sup>st</sup> September 2025 to Friday, 14<sup>th</sup> September 2025 (Exclusive of holidays, Saturday and Sunday).
2. Engine candidates will be examined at TASAC Office, 12<sup>th</sup> Floor PSSSF Golden Jubilee Building House and Deck candidates will be examined at TASAC Office, 8<sup>th</sup> Floor PSSSF Tower House **(Note that, in case of any changes of Oral Examination venue, TASAC will notify the candidates in an ample time)**
3. A candidate for Oral Examination shall apply by submitting application letter and duly completed application form obtained through TASAC website <https://www.tasac.go.tz/> which shall be submitted at least twenty-one (21) days from the date of this announcement. Upon submitting the application letter, a candidate will be issued with the his/her examination number at the registry. **(Note that, candidates for 2<sup>nd</sup> and 3<sup>rd</sup> attempts are required to submit the application letters only including their existing examination numbers for those they have, explaining their intention to re-sit for the Oral Examinations)**
4. The application shall be accompanied by the relevant supplementary documents specified in the Oral Examination application form.
5. Upon being cleared for Oral Examination, the candidate will be required to pay appropriate fee for his/her Oral Examination. The schedule date for payment of Oral Examination fees will be on 26<sup>th</sup> – 27<sup>th</sup> August 2025, and 28<sup>th</sup> – 29<sup>th</sup> August 2025 Orientation for candidates before sitting for Oral examinations which will be conducted at TASAC PSSSF Golden Jubilee offices 12<sup>th</sup> Floor from 1000hrs.
6. Among others, a candidate is required to have appropriate knowledge, understanding and competence of the relevant maritime laws of Tanzania.
7. The “**deadline**” for receiving oral examination applications will be “**18<sup>th</sup> August, 2025**”
8. A candidate who wishes to postpone or change the date of their oral examination after it has been scheduled, he/she must submit a written request to the Registrar, accompanied by valid supporting evidence, explaining their reasons. This request shall be made at least three working days before the scheduled examination date. Failure to appear for the oral examination at the appointed time and place without a valid excuse may result in automatic failure **(For more information contact us through phone no. 0745 237 548 / 0767491081)**
